### **Permission to use video footage**

  - b. withdraw my consent to the Charity storing my contact details on its database;
  - c. withdraw my consent to the Charity storing and transferring the Video Footage and my contact details to a location outside of the EEA;
  - d. access the Video Footage, and any information the Charity holds about me at any time; and

This Agreement and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual dispute or claims) shall be governed by and construed in accordance with the law of England and Wales. Each party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim arising out of or in connection with this agreement or its subject matter or formation (including non-contractual disputes or claims).
